2. Definitions

Community Website, Site: the online platform named The Maloca by Soltara edited by Hivebrite and provided by Gaian Spirit International, Inc., allowing User to benefit from the Service.

Data Protection Law: means the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation) and the Canadian Personal Information Protection and Electronic Documents Act, SC 2000 c 5 or "PIPEDA"
