 - 1. Registration for programs are going to increase by \$200-300+ which is still less than many competitor organizations for CLEs (not at the level of quality of Forum programs)
 - 2. Electronic publications and program brochures
 - 3. Virtual attendance at national meetings will be pulled back
 - 4. Division budgets decreased from \$1,500 to \$500 per bar year
 - 5. A/V availability for Division lunches may be more limited
